Shooting Guide

*****Because of the type of content that we produce, we do not and will not work with anyone who is under the influence of drugs or alcohol. If we suspect that you are not 100% sober we will NOT work with you, will not reimburse you for any travel, hotel or expenses incurred, nor will we pay any agent fees, or any missed shoot fees. You will also not be allowed to shoot with us in the future.*****

*****If you are on any prescription medication prescribed to you by a doctor, or have any physical or mental illnesses (Past or Present) we must know before your booking, as we need to determine if the medication you are prescribed or your illness will affect your ability to work with us. If you have not previously told us in your phone interview about your prescribed medications or your past or present health conditions, we will not work with you and will not pay or reimburse travel, hotel, agent fees or any other expenses incurred. *****

ALL INFORMATION YOU SUBMIT TO US IS CONFIDENTIAL AND WILL NOT BE GIVEN OUT TO ANYONE OR ANY COMPANY.

******IF YOU HAVE BODY PIERCINGS, THEY MUST BE ABLE TO BE REMOVED DURING THE SHOOT IF THE HANDLER FEELS THAT THEY COULD INTERFERE WITH OUR PRODUCTION******

EVERYTHING IS DISCUSSED PRIOR TO SHOOTING AND IS ALL CONSENSUAL

If you cannot finish a shoot, you will be paid a \$100 kill fee and \$150 for each completed scene. This is NOT NEGOTIABLE. You must work the entire day to be paid the entire wage.

PICTURES AND AGE:

If you arrive and the pictures that you sent in with your application DO NOT represent how you look, i.e., you have gained 30 pounds since the pictures were taken, the pictures are more than 6 months old, you have gotten 10 tattoos, the pictures you sent were altered or airbrushed, we will NOT work with you or pay for any travel, lodging, agent fees or any other expenses that you incurred.

If you arrive, and you are not the age that you said you were during the phone interview/and on the bottom of this form, we will NOT work with you, or pay any travel, lodging, or expenses that you incurred.

TRAVEL AND LODGING:

We reimburse up to \$400.00 for travel (i.e. airfare, train or bus) for the MODEL only, (must have receipts and be approved BEFOREHAND by us). We will only reimburse half of the travel if you are shooting with anyone else during the time you are here (i.e. We will share costs with other companies you choose to work with).

If you need to stay in a hotel we will reimburse up to \$100.00 per night for lodging for the MODEL. (Must have receipts and be approved BEFOREHAND by us) Lodging will only be reimbursed for the number of nights you are shooting.

****If for any reason you cannot or will not work the number of days scheduled, you understand we will NOT pay for travel, lodging, agent fees or any other expenses you incurred.****

THERE IS NOBODY ALLOWED ON SET DURING SHOOTING BESIDES THE MODEL AND CREW

You most certainly can have a somebody accompany you to the studio, see where you will be working and who you are working with, however they can not be on set while shooting or preparing for the shoot.

You also must understand that if you are planning on working with other companies while you are in NY, we WILL NOT alter our shooting plan in order to accommodate other companies requirements, for example, the time we begin or end the shoot or if you have a glamour shoot that follows your shoot with us, you must understand that there is a possibility that you may receive some marks or bruises, either intentional or unintentional while working with us. That is just the nature of the job we are hiring for. We may make certain agreements about not leaving marks, but do not plan on it. If you are planning to book a shoot right after ours please make sure they are ok with you having "minor marking" (i.e. the kind that go away in a day or two).

- -You must have a valid US government issued ID WITH YOU at the time of shoot or we CANNOT work with you or pay for any of your travel, lodging, agent fees or any other expenses incurred.
- -Must accept company check made out to you, the model (TD Bank is the bank we use) as form of payment. You will receive a check to reimburse your travel and lodging AFTER the scheduled days of shooting are completed.
- -You will receive a 1099 (tax paperwork) and the payment you receive will be reported to the IRS and you will need to pay taxes on it. Under NO circumstances do we pay the model cash or make out checks to anyone other than the model.

PREPARATION FOR THE SHOOT

- -You should bring two or three COMPLETE outfits (depending on how many days you are scheduled to shoot with us) with you to include panties and bra, socks and shoes, the outfits should be casual, girl next door look, i.e., jeans and a cute top, jean skirt and a sweater and boots, sundress, etcetera. PLEASE DO NOT BRING ANYTHING PLAIN WHITE, FETISH OR ANY STRIPPER WEAR OR STRIPPER SHOES!!!!
- -Please have finger and toenails clean and neat, you DO NOT have to have a manicure, but please remove any old polish that is chipping
- -Please have all hair that you usually remove, freshly removed the morning of the shoot, i.e. leg hair, underarm hair, eye brows, pubic hair.
- -Please bring all hair and makeup supplies with you (which you may have to do yourself) makeup should be natural, NO GLITTER or false eyelashes.
- -PLEASE BE PREPARED TO REMOVE ANY BODY PIERCINGS IF WE FEEL IT COULD IMPEDE WITH PRODUCTION

Please read this carefully and send a reply answering the following four questions if we are working with you for the first time, we cannot proceed otherwise:
